

RESOLUTION NO. 214978

WHEREAS, JEROME E. EGGERS, representing property owners, appealed the decision of the Planning Director in approving the Preliminary Parcel Map of a three parcel, parcel map of Lots 21 and 22 in Block 11 of Sunset Cliffs Subdivision; and

WHEREAS, on November 18, the Planning Commission voted 6 to 1 to deny the appeal and uphold the decision of the Planning Director in approving the Parcel Map; and

WHEREAS, on December 2, 1975, pursuant to the provisions of Section 101.0506 of the San Diego Municipal Code, JEROME E. EGGERS, representing property owners, appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on December 30, 1975, and testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; and

WHEREAS, the City Council in considering said appeal is empowered by the provisions of Municipal Code, Section 101.0506, to affirm, reverse or modify in whole or in part any determination of the Planning Commission, subject to the limitations as are placed upon the Planning Commission by the Municipal Code; NOW, THEREFORE,


