That the expenditure of \$10,066.50 is hereby authorized from the Torrey Pines Golf Course Improvement Fund (Fund No. 248) of the City of San Diego solely and exclusively for the purpose of providing funds for the purchase of ONE HUNDRED (100) EACH TORREY PINE TREES in the City of San Diego, and related costs.
