AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by BYRL D. PHELPS, Registered Civil Engineer, entitled
"FIESTA TIME UNIT NO. 1 Being a portion of Lot 261 of Pacifica
Hills Unit No. 10, in the City of San Diego, County of San Diego,
State of California, according to Map No. 7012, filed in the
office of the County Recorder of San Diego County, August 3,
1971.", is made in the manner and form prescribed by law and
conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and
accepted.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges
receipt of assurance from the subdivider, TIME DEVELOPMENT CO.,
a partnership, that said subdivider will comply with the
Affirmative Fair Housing Plan for his proposed subdivision,
as outlined in Document No. 753597, on file in the office
of the City Clerk, and in reliance on said assurance does
hereby accept the final map of FIESTA TIME UNIT NO. 1.


