
Adopted on DEC 8 1975

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, acting by and through its Department of Transportation, for the purchase of an air study report for the improvement of IMPERIAL AVENUE, from 47th Street to 61st Street, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753794.

BE IT FURTHER RESOLVED, that the expenditure of \$3,500 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced purchase.
