

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MANLEY W. EDWARDS, an individual, for full-time services to assist the City Manager, City Attorney, Water Utilities Department, and other departments concerned with public utility matters from February 1, 1976 to January 31, 1977, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753811.

BE IT FURTHER RESOLVED, that the expenditure of \$29,900 is hereby authorized out of Water Utilities Operating Fund 500 (69.67 - 3295) for the sole and exclusive purpose of providing funds for the above services.
