WHEREAS, The City of San Diego has entered into a grant agreement with the Department of Housing and Urban Development (HUD) to carry out the Housing and Community Development Block Grant Program within the City of San Diego; and

WHEREAS, the City Manager, acting through the Human Resources Department, has been given the duties and responsibilities for implementing the Community Development Block Grant Senior Citizens Project for the City pursuant to the provisions of the City's contract with the United States Department of Housing and Urban Development; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Senior Citizens Federation, Inc., which will provide a hot meals program as part of the Senior Citizens Project, to be operated from January 1, 1976, to June 30, 1976, and supervised by the Human Resources Department pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 753815.

2. That an amount not to exceed \$46,152 in Community Development Block Grant funds be expended for this said purpose and that revenue up to and in excess of \$10,000 in \$.50 per meal food revenues be used for authorized program operational costs.
