AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR, BY AMENDING DOCUMENT NO. 746519, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE CAPITAL IMPROVEMENTS PROGRAM (FUND 245), BY ADDING PROJECT NO. 23-174, CONSTRUCTION OF MEMORIAL PARK AND RECREATION CENTER GYMNASIUM FLOOR TO THE FISCAL YEAR 1974-75 PROGRAM IN THE PARK AND RECREATION DEPARTMENT, RECREATION DIVISION 22.00; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER THE NECESSARY MONIES FROM VARIOUS C.I.P. PROJECTS WITHIN THE 245 FUND.

WHEREAS, the Capital Improvements Program in the annual budget for fiscal year 1974-75 contains an improvement project to reconstruct the gymnasium floor at Memorial Park and Recreation Center; and

WHEREAS, said project number 23-174 is presently scheduled for construction in fiscal year 1980; and

WHEREAS, the gymnasium floor was damaged in early December, 1974, due to runoff from rainfall flowing into the building and causing the floor to buckle and warp; and

WHEREAS, the facility is heavily used by both City and school athletic programs and all scheduled activity has ceased due to the damage to and unusable condition of the floor; and

WHEREAS, said damage and unusable condition now require the project to be accelerated to this fiscal year; and

MAY 4 1978 U2124 WHEREAS, the conditions that caused the flooding and resulting damage will be corrected as part of a School District project currently in process; and

WHEREAS, funds for this project are available from savings in other C.I.P. projects; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11348 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Page 394 of Document No. 746519, as adopted and amended therein, relating to the Capital Improvements Program (Fund 245) of the Recreation Division by transferring Project No. 23-174, Memorial Park and Recreation Center Gymnasium Floor from projected fiscal year 1980 to fiscal year 1974-75 and adding said Project No. 23-174 on Page 394 to the Park and Recreation Department Capital Improvements Detail for Recreation Division (22.00) for final fiscal year 1975.

Section 2. That the Auditor and Comptroller be and he is hereby fully authorized and directed to transfer within the 245 Fund the sum of \$48,877 to C.I.P. Project No. 23-174, Construction of Memorial Park and Recreation Center Gymnasium Floor from the following sources:
