## ORDINANCE NO. 11496 (New Series)

FEB 27 1975

AN ORDINANCE INCORPORATING LOT 4, BLOCK 1, AND A PORTION OF TATUM STREET CLOSED, C.C.C. TATUM'S BAY HILLS MESA, AND LOT 557, CLAIREMONT MANOR UNIT 4, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE. AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11241 (NEW SERIES), ADOPTED FEBRUARY 21, 1974, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within 18 months of the effective date of this ordinance, a parcel map for lot consolidation is recorded on Lot 4, Block 1, and a portion of Tatum Street closed, C.C.C. Tatum's Bay Hills Mesa, and Lot 557, Clairemont Manor Unit 4, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2786, the provisions of Section 101.0423 of the San Diego Municipal Code shall attach and become applicable to the said land and shall be incorprated into the CO Zone, as described by Section 101.0423, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2786, filed in the office of the City Clerk as Document No. 750052.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 11241 (New Series), adopted February 21, 1974, of the Ordinances of The City of San Diego be, and it is hereby
