AN ORDINANCE AMENDING ORDINANCE NO. 11625 (NEW SERIES), ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1975-76," BY AMENDING EXHIBIT C THEREOF TO DELETE THE UNCLASSIFIED POSITION OF PRINCIPAL ASSISTANT TO THE CITY COUNCIL.

WHEREAS, the establishment of separate departments of the City Council for administrative purposes has significantly eliminated the role of and requirement for a Principal Assistant to the City Council; and

WHEREAS, such duties as have previously been assigned to said Principal Assistant have been assumed almost entirely by individual Council assistants; and

WHEREAS, it has been determined that the intra-Council liaison can be effectuated with reduced administrative support to the Deputy Mayor for the purpose of accomplishing the Deputy Mayor's duties in regard to the affairs of the Council as a whole; and

WHEREAS, action in this regard is being promulgated to establish a division of Council assistance to serve the Deputy Mayor in such capacity as is required by Charter and ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 11625 (New Series) entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR
