AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLANNING AREA IV, LOCATED SOUTH OF MARILOU ROAD, WEST OF EUCLID AVENUE, AND NORTH OF BEECH STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 AND R-2 ZONES AS DEFINED BY SECTION 101.0411 AND SECTION 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Planning Area IV, located south of Marilou Road, west of Euclid Avenue, and north of Beech Street, in the City of San Diego, California, within the boundary of the district designated "R-3" and "R-2" on Zone Map Drawing No. C-457.2, filed in the office of the City Clerk as Document No. 753729, be, and it is hereby incorporated into R-3 and R-2 Zones as such zones are described and defined by Section 101.0411 and Section 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 9207 (New Series), adopted May 28, 1964, and Ordinance No. 5515 (New Series), adopted March 5, 1953, of the Ordinances of The City of San Diego, be and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
