AN ORDINANCE INCORPORATING PROPERTY IN THE SAN YSIDRO PLAN AREA GENERALLY BOUNDED ON THE WEST BY THE WESTERLY BOUNDARY OF SECTION 1, TOWNSHIP 19 SOUTH, RANGE 2 WEST, ON THE NORTH BY A LINE APPROXIMATELY 270 FEET SOUTH AND PARALLEL TO BOLTON HALL ROAD AND SUNRISE DRIVE, ON THE EAST BY WILLOW ROAD, AND ON THE SOUTH BY ENSENDA STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCES NO. 8028 (NEW SERIES) AND 10862 (NEW SERIES), ADOPTED DECEMBER 18, 1958, AND JUNE 29, 1972, RESPECTIVELY, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the San Ysidro Plan Area generally bounded on the west by the westerly boundary of Section 1, Township 19 South, Range 2 West, on the north by a line approximately 270 feet south and parallel to Bolton Hall Road and Sunrise Drive, on the east by Willow Road, and on the south by Ensenda Street, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. C-463.2, filed in the office of the City Clerk as Document No. 754457, be, and it is hereby incorporated into R-2A Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.


Section 2. That Ordinance Nos. 8028 (New Series) and 10862 (New Series), adopted December 18, 1959, and June 29, 1972, respectively, of the Ordinances of The City of San Diego, be, and they are hereby repealed insofar as they conflict herewith.
