AN ORDINANCE INCORPORATING THAT PROPERTY IN THE UPTOWN COMMUNITY PLAN AREA GENERALLY BOUNDED ON THE WEST BY STATE HIGHWAY 163, ON THE NORTH AND EAST BY BUCHANAN AVENUE, AND ON THE SOUTH BY WASHINGTON STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0407 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Uptown Community Plan Area generally bounded on the west by State Highway 163, on the north and east by Buchanan Avenue, and on the south by Washington Street, in the City of San Diego, California, within the boundary of the district designated "R-1-5" and "R-2" on Zone Map Drawing No. C-469.1, filed in the office of the City Clerk as Document No. 754525, be, and it is hereby incorporated into R-1-5 and R-2 Zones, as such zones are described and defined by Sections 101.0407 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1930 and Ordinance No. 190 (New Series), adopted March 27, 1933, be and the same are hereby repealed insofar as they conflict herewith.


