AN ORDINANCE INCORPORATING THAT PROPERTY IN THE UPTOWN COMMUNITY PLAN AREA GENERALLY BOUNDED ON THE WEST BY RICHMOND STREET, ON THE NORTH BY WASHINGTON STREET, ON THE EAST BY PARK BOULEVARD, AND ON THE SOUTH BY UNIVERSITY AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Uptown Community Plan Area generally bounded on the west by Richmond Street, on the north by Washington Street, on the east by Park Boulevard, and on the south by University Avenue, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-468.1, filed in the office of the City Clerk as Document No. 754527, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1939, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of introduction of this ordinance.
