AN ORDINANCE INCORPORATING THAT PROPERTY IN THE UPTOWN COMMUNITY PLAN AREA GENERALLY LOCATED ALONG SIXTH AVENUE BETWEEN ROBINSON AVENUE AND UPAS STREET, AND WEST OF STATE HIGHWAY 163, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A, R-1-5 and R-1-40 ZONES AS DEFINED BY SECTIONS 101.0412 AND 101.0407, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Uptown Community Plan Area, generally located along Sixth Avenue between Robinson Avenue and Upas Street, and west of State Highway 163, in the City of San Diego, California, within the boundary of the district designated "R-3A," "R-1-5," and "R-1-40" on Zone Map Drawing No. C-467.1, filed in the office of the City Clerk as Document No. 754528, be, and it is hereby incorporated into R-3A, R-1-5 and R-1-40 zones as such zones are described and defined by Sections 101.0412 and 101.0407, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1930, of the Ordinances of The City of San Diego, be and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of introduction of this ordinance.
