AN ORDINANCE INCORPORATING THAT PROPERTY IN THE UPTOWN COMMUNITY PLAN AREA, LOCATED EAST OF FRONT STREET AND WEST OF FOURTH AVENUE, GENERALLY BETWEEN UNIVERSITY AVENUE AND UPAS STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That property in the Uptown Community Plan Area, located east of Front Street and west of Fourth Avenue, generally between University Avenue and Upas Street, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. c-467.1, filed in the office of the City Clerk as Document No. 754528, be, and it is hereby incorporated into "R-3A" Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1930, and Ordinance No. 7108 (New Series), adopted August 16, 1956, of the Ordinances of The City of San Diego, be and the same are hereby repealed insofar as they conflict herewith.


