AN ORDINANCE INCORPORATING THAT PROPERTY IN THE UPTOWN COMMUNITY PLAN AREA GENERALLY BOUNDED ON THE WEST BY BRANT STREET, ON THE NORTH BY PENNSYLVANIA AVENUE AND ROBINSON AVENUE, ON THE EAST BY FRONT STREET, AND ON THE SOUTH BY BROOKES AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-40 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Uptown Community Plan Area generally bounded on the west by Brant Street, on the north by Pennsylvania Avenue and Robinson Avenue, on the east by Front Street, and on the south by Brookes Avenue, in the City of San Diego, California, within the boundary of the district designated "R-1-40" on Zone Map Drawing No. C-467.1, filed in the office of the City Clerk as Document No. 754528, be, and it is hereby incorporated into R-1-40 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, adopted October 20, 1930, of the Ordinances of The City of San Diego, be and the same is hereby repealed insofar as it conflicts herewith.
