

ORDINANCE NO. 11802

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SAN YSIDRO PLAN AREA GENERALLY BOUNDED ON THE WEST BY AVERIL ROAD, ON THE NORTH BY THE EASTERLY PROLONGATION OF VISTA LANE, ON THE EAST BY BEYER BOULEVARD, AND ON THE SOUTH BY SAN YSIDRO BOULEVARD AND THE SD&AE RAILROAD UNDERPASS AT I-805, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A and R-3 ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0411, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the San Ysidro Plan Area generally bounded on the west by Averil Road, on the north by the easterly promulgation of Vista Lane, on the east by Beyer Boulevard, on the south by San Ysidro Boulevard and the SD&AE Railroad Underpass at I-805, in the City of San Diego, California, within the boundary of the district designated "R-2A" and "R-3" on Zone Map Drawing No. C-463.3, filed in the office of the City Clerk as Drawing No. 754505, be, and it is hereby incorporated into R-2A and R-3 Zones, as such zones are described and defined by Sections 11.0410 and 101.0411, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 8020 (New Series), adopted December 18, 1958, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
