AN ORDINANCE INCORPORATING LOT 1 AND A PORTION OF LOT 2, BLOCK 13, BROOKES ADDITION, LOCATED AT THE SOUTHEAST CORNER OF BROOKES AND FOURTH AVENUES, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 1 and a portion of Lot 2, Block 13, Brookes Addition, located at the southeast corner of Brookes and Fourth Avenues, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2891, filed in the office of the City Clerk as Document No. 754290, and provided the conditions as required by the Engineering and Development Director for park fees are met, be and it is hereby incorporated into CO Zone as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1930, of the Ordinances of The City of San Diego, be and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
