AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 3,  
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING  
SECTION 63.20.28 RELATING TO ENDANGERING  
AQUATIC ACTIVITIES.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter VI, Article 3, of the San Diego  
Municipal Code be and it is hereby amended by adding  
Section 63.20.28 to read as follows:

SEC. 63.20.28 ENDANGERING AQUATIC ACTIVITIES

No person shall use any surfboard, paddleboard,  
bellyboard, skim board, ski, canoe, boat or vessel  
of any type, or any similar device in a negligent  
manner so as to endanger the life, limb or property  
of another person.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
