Section 2. That the Auditor and Comptroller be and he is hereby fully authorized and directed to transfer within the 245 Fund the sums of \$104,000 from C.I.P. No. 29-156(5) and \$102,000 from C.I.P. No. 29-160.1 to provide funds for the above C.I.P. Project No. 29-205.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
