AN ORDINANCE AMENDING ORDINANCE NO. 11650 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1975-76 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 750397, AS ADOPTED AND AMENDED THEREIN, RELATING TO CAPITAL IMPROVEMENTS PROGRAM, FUND 245, BY ADDING PROJECT NO. 29-235, ENTITLED "ACQUISITION OF ALLIED GARDENS NEIGHBORHOOD PARK NO. 3"; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER WITHIN THE 245 FUND THE SUMS OF \$104,000 FROM C.I.P. NO. 29-156(5) AND \$102,000 FROM C.I.P. NO. 29-160.1 TO PROVIDE FUNDS FOR THE ABOVE CAPITAL IMPROVEMENTS PROJECT NO. 29-235.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11650 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1975-76 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and it is hereby amended by amending Document No. 750397, as adopted and amended therein, relating to Capital Improvements Program, Fund 245, by adding Project No. 29-235, entitled "Acquisition of Allied Gardens Neighborhood Park No. 3."

Section 2. That the Auditor and Comptroller be and he is hereby fully authorized and directed to transfer within the 245 Fund the sums of \$104,000 from C.I.P. No. 29-156(5) and \$102,000 from C.I.P. No. 29-160.1 to provide funds for the above C.I.P. Project No. 29-235.
