

ORDINANCE NO. 11830

AN ORDINANCE INCORPORATING THE SAN DIEGUITO RIVER FLOODPLAIN, GENERALLY BOUNDED BY THE CITY OF DEL MAR ON THE WEST, UNINCORPORATED AREAS OF THE COUNTY OF SAN DIEGO ON THE NORTH AND EAST, AND BY BLACK MOUNTAIN ROAD ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO FLOODWAY (FW) AND FLOODPLAIN FRINGE (FPF) OVERLAY ZONES, AS DEFINED BY SECTIONS 101.0403 (NEW SERIES) AND 101.0403.1 (NEW SERIES) OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the San Dieguito River Floodplain, generally bounded by the City of Del Mar on the west, unincorporated areas of the County of San Diego on the north and east, and by Black Mountain Road on the south, in the City of San Diego, California, within the boundaries of the districts designated "FW" and "FPF" on that certain Zone Map Drawing No. C-461, filed in the office of the City Clerk as Document No. 755002, be incorporated into FW and FPF Zones as defined by Section Nos. 101.0403 (New Series) and 101.0403.1 (New Series), respectively, of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
