AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 14 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.1405 RELATING TO SOLICITOR REGISTRATION CARDS.

WHEREAS, all persons now applying for solicitor registration cards do not have to pay a fee for such application nor for reapplication upon expiration of such cards; and

WHEREAS, the City is now incurring losses approximating \$8,800 per year to process such applications; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 14 of the San Diego Municipal Code be and the same is hereby amended by amending Section 33.1405 to read as follows:

SEC. 33.1405 COMPLIANCE WITH REQUIREMENTS--ISSUANCE OF REGISTRATION CARD

Registration cards shall be issued to all applicants who have paid an application fee of two dollars and twenty-five cents (\$2.25) and who have complied with Section 33.1403 of this division unless the proposed sales proposition shall include some element of trickery, fraud or deceit or the applicant has been convicted of a felony involving moral turpitude within the past seven years or has been convicted of a felony involving moral turpitude and is on parole or has been convicted of any crime involving sexual matters within the previous ten years, in which case, in the interest of public safety and protection,

the applicant shall not be registered or license issued. Registration cards shall be valid for one (1) year from the date of issuance. Registration cards may be reissued upon the payment of a fee of one dollar (\$1.00).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
