When a question involving the interpretation of the intent and purpose of any provisions of this Code or the suitability of alternate materials and types of construction is presented to the Chief, he may request the Board of Appeals and Advisors to investigate such matters under the procedure established in Section 91.01.0204 of the San Diego Municipal Code.
