AN ORDINANCE AMENDING CHAPTER V, ARTICLE 5,  
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING  
SECTION 55.01.215 RELATING TO THE BOARD OF

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter V, Article 5, of the San Diego  
Municipal Code be and it is hereby amended by adding  
Section 55.01.215 to read as follows:

SEC. 55.01.215 SEC. 1.215 OF THE 1973 UNIFORM  
FIRE CODE AMENDED

Sec. 1.215. BOARD OF APPEALS. When a question  
involving the interpretation of the intent and  
purpose of any provisions of this Code or the  
suitability of alternate materials and types of  
construction is presented to the Chief, he may  
request the Board of Appeals and Advisors to  
investigate such matters under the procedure  
established in Section 91.01.0204 of the San  
Diego Municipal Code.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
