AN ORDINANCE INCORPORATING PARCELS 1 AND 2, PARCEL MAP NO. 2486, BEING LOT 1, STALMER TRACT, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11349 (NEW SERIES), ADOPTED JULY 18, 1974, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcels 1 and 2, Parcel Map No. 2486, being Lot 1, Stalmer Tract, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing B-2898, filed in the office of the City Clerk as Document No. 754906, be, and it is hereby incorporated into R-2A Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11349 (New Series), adopted July 18, 1974, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
