
AN ORDINANCE REPEALING ORDINANCE NO. 7607 (NEW SERIES), ADOPTED SEPTEMBER 26, 1957, OF THE ORDINANCES OF THE CITY OF SAN DIEGO IN REGARD TO SETBACK REGULATIONS ALONG STREETS WITHIN THE SOUTH BAY ANNEXATION AREA IN THE CITY OF SAN DIEGO, CALIFORNIA.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 7607 (New Series), adopted September 26, 1957, of the Ordinances of The City of San Diego, be and it is hereby repealed.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
