WHEREAS, the fiscal year 1976 Capital Improvements Program contains CIP No. 21-417, entitled "Morley Field Tennis Clubhouse, Enlarge Men's Locker Room and Shower Facility"; and

WHEREAS, the cost of construction of said project is financed with 1966 Park Bond Funds; and

WHEREAS, there appeared a need for such improvement at the time of authorization; and

WHEREAS, the City has been advised subsequently that the use pattern at the tennis facility has changed and that additional locker and shower space is not required; and

WHEREAS, the Balboa Tennis Club and San Diego Tennis Council have requested that funds allocated for this project be reallocated to provide lighting for additional tennis courts and further provide an improved and enlarged tennis backboard; and

WHEREAS, no change in cost for the recommended project is anticipated; and
