AN ORDINANCE AMENDING ORDINANCE NO. 11650 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1975-76 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 750397, AS ADOPTED AND AMENDED THEREIN, RELATING TO CAPITAL IMPROVEMENTS PROGRAM, FUND 725, BY CHANGING PROJECT NO. 21-417, ENTITLED "MORLEY FIELD TENNIS CLUBHOUSE, ENLARGE MEN'S LOCKER ROOM AND SHOWER FACILITY," TO READ "MORLEY FIELD TENNIS CENTER, LIGHT ADDITIONAL TENNIS COURTS AND CONSTRUCT TENNIS BACKBOARD."

WHEREAS, the fiscal year 1976 Capital Improvements Program contains CIP No. 21-417, entitled "Morley Field Tennis Clubhouse, Enlarge Men's Locker Room and Shower Facility"; and

WHEREAS, the cost of construction of said project is financed with 1966 Park Bond Funds; and

WHEREAS, there appeared a need for such improvement at the time of authorization; and

WHEREAS, the City has been advised subsequently that the use pattern at the tennis facility has changed and that additional locker and shower space is not required; and

WHEREAS, the Balboa Tennis Club and San Diego Tennis Council have requested that funds allocated for this project be reallocated to provide lighting for additional tennis courts and further provide an improved and enlarged tennis backboard; and

WHEREAS, no change in cost for the recommended project is anticipated; and

WHEREAS, on June 17, 1975, the Park and Recreation Board recommended approval of this change; NOW, THEREFORE,


BE IT ORDAINED, by the Council of The City of San Diego, as follows:
