AN ORDINANCE AMENDING ORDINANCE NO. 11650 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1975-76 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY TRANSFERRING PRIOR YEAR REVENUE SHARING SURPLUS AND UNENCUMBERED FUNDS AND 3021 TRUST FUND MONIES TO THE HUMAN RESOURCES DEPARTMENT FOR THE PURPOSE OF AUGMENTING 05.61, HUMAN CARE SERVICES PROGRAM, RECREATION SUPPORT PROGRAM.

WHEREAS, the Public Services and Safety Committee was informed of tentative plans for the 1976 Recreation Support Program (RSP); and

WHEREAS, RSP has been funded primarily by revenue sharing funds; and

WHEREAS, in order to make available necessary revenue sharing funds for this summer's program, prior year unencumbered funds must be made available; and

WHEREAS, \$98,137 in refunds from prior year Human Care Services Programs and \$5,202 in prior year unencumbered funds are now available for transfer and an additional \$1,739 is also available for transfer from the Convair Charity portion of the 3021 Trust Fund; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11650 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1975-76 AND APPROPRIATING THE NECESSARY MONEY



TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by transferring to the fiscal year 1976 Human Resources Department, Fund 100, Recreation Support Program 05.61, the sum of \$105,078 from the following sources: \$98,137 from prior year Human Care Program Revenue Sharing Funds; \$5,202 from prior year 100 Fund, Activity 05.61 unencumbered appropriations; and \$1,739 from the 3021 Trust Fund, unobligated Convair Donations, said total sum to be used for the operation of the 1976 Recreation Support Program.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


