AN ORDINANCE ESTABLISHING A NEW PARKING METER ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Pursuant to the authority of Section 22508 of the California Vehicle Code, and in accordance with the provisions of Chapter VIII of the San Diego Municipal Code, a parking meter zone is hereby established in the following location:

South side of RUSS BOULEVARD, between Twelfth Avenue and Sixteenth Street.

The above-described meters shall be in parking meter Zone A as described in Section 86.11 of the San Diego Municipal Code.

Section 2. A parking time limit of two hours shall be in effect in the above-described location between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted.

- Section 3. The installation of parking meters and the necessary signs and markings be, and the same are hereby authorized to be made in the above-described location.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
