AN ORDINANCE AMENDING ORDINANCE NO. 11743 (NEW SERIES), ADOPTED DECEMBER 24, 1975, INCORPORATING A PORTION OF THE SOUTHEAST 1/4 OF SECTION 27, TOWNSHIP 18 SOUTH, RANGE 2 WEST, SBBM IN THE CITY OF SAN DIEGO, CALIFORNIA INTO R-2 ZONE, AS DEFINED BY SECTION 104.0409 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, Ordinance No. 11743 (New Series), adopted December 24, 1975, provided that the R-2 Zone would attach if a final map was recorded on or before May 11, 1976; and

WHEREAS, a request has been received to extend the time within which a final map may be recorded to effect the zone change contemplated by Ordinance No. 11743 (New Series); and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission and allow the completion of arrangements for financing under applicable provisions of the United States Department of Housing and Urban Development; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The CIty of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 11743 (New Series), adopted December 24, 1975, be, and it is hereby amended to read as follows:

Section 1. That in the event that a portion of the Southeast 1/4 of Section 27, Township 18 South, Range 2 West, SBBM, in the City of San Diego,
