AN ORDINANCE INCORPORATING LOTS 1-3, BECK SUBDIVISION, LOCATED SOUTH OF IMPERIAL AVENUE AND EAST OF WOODMAN STREET IN THE SKYLINE-PARADISE HILLS AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section. That Lots 1-3, Beck Subdivision, located south of Imperial Avenue and east of Woodman Street in the Skyline-Paradise Hills Area, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. C-459.3, filed in the office of the City Clerk as Document No. 754853, be and it is hereby incorporated into R-1-5 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 116 (New Series), adopted January 3, 1933, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
