AN ORDINANCE INCORPORATING LOTS 27-42, BLOCK 79, PACIFIC BEACH SUBDIVISION OF PORTION OF ACRE LOTS AND BLOCKS 150 AND 151, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO RV ZONE, AS DEFINED BY SECTION 101.0414 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9089 (NEW SERIES), ADOPTED OCTOBER 8, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 27-42, Block 79, Pacific Beach
Subdivision of portion of Acre Lots and Blocks 150 and 151,
in the City of San Diego, California, within the boundary
of the district designated "RV" on Zone Map Drawing
No. B-2899, filed in the office of the City Clerk as Document
No. 755477, be, and it is hereby incorporated into RV Zone,
as such zone is described and defined by Section 101.0414
of the San Diego Municipal Code.

Section 2. That Ordinance No. 9089 (New Series), adopted October 8, 1964, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
