

AN ORDINANCE OF THE CITY OF SAN DIEGO CONSENTING TO THE TRANSFER OF THE NON-EXCLUSIVE RIGHT, PRIVILEGE AND FRANCHISE TO LAY AND USE LINES, WIRES, COAXIAL CABLE AND APPURTENANCES FOR TRANSMITTING, DISTRIBUTING AND SUPPLYING RADIO AND TELEVISION ANTENNA SERVICE ALONG, ACROSS AND UPON THE PUBLIC STREETS, WAYS, ALLEYS AND PLACES WITHIN THE CITY OF SAN DIEGO KNOWN AS THE MIRA MESA AREA FROM PENASQUITOS ANTENNA SYSTEM, INC. TO AMERICAN TELEVISION AND COMMUNICATIONS CORPORATION.

WHEREAS, The City of San Diego has by Ordinance No. 10502 (N.S.) granted the nonexclusive right, privilege and franchise to lay and use lines, wires, coaxial cable and appurtenances for transmitting, distributing and supplying radio and television antenna service along, across and upon the public streets, ways, alleys and places within the City of San Diego known as the Mira Mesa area to Penasquitos Antenna System, Inc., as more particularly set forth in said ordinance; and

WHEREAS, Penasquitos Antenna System, Inc. has by a letter dated April 5, 1976, a copy of which is on file in the office of the City Clerk as Document No. 755707, requested The City of San Diego to consent to the transfer of said franchise to American Television and Communications Corporation pursuant to the provisions of Section 8 of Ordinance No. 10502 (N.S.); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:



Section 1. That The City of San Diego does by this ordinance consent to the transfer to American Television and Communications Corporation of the franchise heretofore granted by Ordinance No. 10502 (N.S.) to Penasquitos Antenna System, Inc. subject to all the terms and conditions contained in said Ordinance No. 10502 (N.S.).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
