AN ORDINANCE INCORPORATING PARCEL 1, PARCEL MAP NO. 2219 (PORTION OF LOT F OF PARTITION OF A PORTION OF LOT 70, RANCHO MISSION OF SAN DIEGO, SCC 15191), IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10175 (NEW SERIES), ADOPTED NOVEMBER 6, 1969, AND ORDINANCE NO. 10737 (NEW SERIES), ADOPTED DECEMBER 7, 1971, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Parcel 1, Parcel Map No. 2219 (portion of Lot F of a partition of a portion of Lot 70, Rancho Mission of San Diego, SCC 15191), in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-2905, filed in the office of the City Clerk as Document No. 755944, be, and it is hereby incorporated into R-2A Zone as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10175 (New Series), adopted November 6, 1969, and Ordinance No. 10737 (New Series), adopted December 7, 1971, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
