AN ORDINANCE INCORPORATING PARCEL 1, PARCEL MAP 1260, BEING A PORTION OF PUEBLO LOT 1262, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9926 (NEW SERIES), ADOPTED DECEMBER 12, 1968 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel 1, Parcel Map 1260, being a portion of Pueblo Lot 1262, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2906, filed in the office of the City Clerk as Document No. 756113, be, and it is hereby incorporated into CO Zone as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code, subject to the requirements of the Engineering and Development Director for park fees.

Section 2. That Ordinance No. 9926 (New Series), adopted December 12, 1968, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
