
AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST OF THE PACIFIC OCEAN AND WEST OF NORTH TORREY PINES ROAD, AND BETWEEN TORREY PINES SCENIC DRIVE ON THE NORTH AND CAMINO DEL ORO, PRESTWICK DRIVE, AND DUNAWAY DRIVE ON THE SOUTH, IN THE LA JOLLA COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE HR OVERLAY ZONE AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego,
 as follows:

Section 1. That those hillsides east of the Pacific Ocean and west of North Torrey Pines Road, and between Torrey Pines Scenic Drive on the north and Camino Del Oro, Prestwick Drive, and Dunaway Drive on the south, in the La Jolla Community Area, in the City of San Diego, California, within the boundary of the district designated "HR Overlay Zone" on Zone Map Drawing No. C-473.1, filed in the office of the City Clerk as Document No. 756225, be and it is hereby incorporated into the HR Overlay Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
