AN ORDINANCE INCORPORATING LOTS 25 AND 26, BLOCK 221, PACIFIC BEACH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 5831 (NEW SERIES), ADOPTED OCTOBER 29, 1953, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, a parcel map for lot consolidation is recorded on Lots 25 and 26, Block 221, Pacific Beach, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-2914, the provisions of Section 101.0410 of the San Diego Municipal Code shall attach and become applicable to the said land and the said land shall be incorporated into the R-2A Zone, as described and defined by Section 101.0410, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2914, filed in the office of the City Clerk as Document No. 756289.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 5831 (New Series), adopted October 29, 1953, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.
