franchise to American Television and Communications Corporation pursuant to the provisions of Section 6 of Ordinance No. 39085 (N.S.); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That The City of San Diego does by this ordinance consent to the transfer to American Television and Communications Corporation of the franchise heretofore granted by Ordinance No. 9085 (N.S.) to Southwestern Cable Company subject to all the terms and conditions contained in said Ordinance No. 9085 (N.S.).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
