AN ORDINANCE INCORPORATING PORTIONS OF LOTS 8 AND 9, TROJAN HEIGHTS, AND PORTIONS OF 54TH PLACE, 54TH STREET, AND TROJAN AVENUE TO BE VACATED, LOCATED ON THE SOUTH SIDE OF TROJAN AVENUE BETWEEN 54TH STREET AND 54TH PLACE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13559, APPROVED JULY 11, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 8 and 9, Trojan Heights, and portions of 54th Place, 54th Street, and Trojan Avenue to be vacated, located on the south side of Trojan Avenue between 54th Street and 54th Place, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2916, filed in the office of the City Clerk as Document No. 757200, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code, subject to the Engineering and Development Director's requirements for payment of park fees.

Section 2. That Ordinance No. 13559, approved July 11, 1932, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.
