
AN ORDINANCE INCORPORATING THOSE HILLSIDES WEST OF PARK RIDGE BOULEVARD AND EAST OF THE SAN DIEGO RIVER, AND BETWEEN MISSION GORGE ROAD ON THE NORTH AND ZION AVENUE, WARING ROAD, AND NAVAJO ROAD ON THE SOUTH, IN THE NAVAJO COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO HR (HILLSIDE REVIEW) OVERLAY ZONE AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those hillsides west of Park Ridge Boulevard and east of the San Diego River, and between Mission Gorge Road on the north and Zion Avenue, Waring Road, and Navajo Road on the south, in the Navajo Community Area, in the City of San Diego, California, within the boundary of the district designated "HR" on Zone Map Drawing No. C-503, filed in the office of the City Clerk as Document No. 757201, be, and they are hereby incorporated into HR Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
