AN ORDINANCE AMENDING CHAPTER-III, ARTICLE 1, DIVISION 3 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 31.0302 RELATING TO BUSINESS LICENSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 1, Division 3 of the San Diego Municipal Code be and the same is hereby amended by amending Section 31.0302 to read as follows:

SEC. 31.0302 LICENSES--TWO OR MORE BUSINESSES AT SAME LOCATION

Whenever any person is engaged in two or more retail businesses at the same location, or in a retail? and wholesale business at the same location, or has two or more wholesale businesses at the same location, or has at the same location a retail business and a business of leasing, servicing or repairing goods of the same type as those sold at retail at that location, or has a service or repair business and also sells products of the same type as those products serviced or repaired at that location, such person shall not be required to obtain licenses for the conducting of each of such businesses, but shall obtain a single license for the conduct of all such businesses, and the average number of employees of all such businesses so conducted shall be used as a basis for computing the amount of license fee to be paid for the conduct of all such businesses.

Whenever any person is engaged in two or more retail businesses at the same location, or in a retail and wholsale husinesses at the same location, or has two or more wholsale husinesses at the same location, or has a two or more wholsale businesses at the same location, or has a trail business and a business of leasing, servicing or repairing goods of the same type as those sold at retail at that location, or has a service or repair business and also sells products of the same type as those sold at retail at that location, such person shall not be required to phtain licenses for the conduct of all-such businesses, but shall obtain a single license for the conduct of all-such businesses so conducted shall be used as a basis for computing the amount of license feets. Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its pushage.
