AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 16, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 33.1625.9 AND 33.1625.13 AND AMENDING SECTIONS 33.1625.5(d) AND 33.1625.6; AMENDING CHAPTER III, ARTICLE 1, DIVISION 1, BY ADDING SECTION 31.0110(t); AND AMENDING CHAPTER III, ARTICLE 1, DIVISION 3, BY ADDING SECTION 31.0396 RELATING TO CARDROOM TABLE LICENSE TAX.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 16, of the San Diego Municipal Code be and it is hereby amended by repealing the following sections:

SEC. 33.1625.9 CHECK CASHING PROHIBITED

SEC. 33.1625.13 LICENSE FEE

Section 2. That Chapter III, Article 3, Division 16, of the San Diego Municipal Code be and it is hereby amended by amending Sections 33.1625.5(d) and 33.1625.6 to read as follows:

SEC. 33.1625.5 REGULATIONS

(d) Not more than eight (8) players shall be permitted at any one card table.

SEC. 33.1625.6 CHARGES

No charge in excess of Two Dollars and Fifty Cents (\$2.50) per hour shall be collected from any player for the privilege of participating in any game.

Section 3. That Chapter III, Article 1, Divisions 1 and 3, of the San Diego Municipal Code be and it is hereby amended by adding Sections 31.0110(t) and 31.0396 to read as follows:

SEC. 31.0110 LICENSE TAX--DEFINITIONS

(t) "Cardroom Table." The words "cardroom table" shall mean any table used or intended to be used for the playing of cards in any cardroom.

SEC. 31.0396 LICENSE TAX--CARDROOM TABLE

There shall be collected for each cardroom table licensed hereunder, the sum of Thirty Dollars (\$30.00) per table per month for the first two tables and Forty Dollars (\$40.00) per table per month for each additional table, payable quarterly in advance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
