AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.02 AND ADDING SECTION 86.02.2, RELATING TO PARKING.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be and it is hereby amended by amending Section 86.02, to read as follows:


SEC. 86.02 PARKING

No person shall park, stand or stop any vehicle unless both right wheels are within eighteen inches (18") of the curb or edge of the street, subject, however, to the provisions of Sections 86.02.1 and 86.02.2. When lines indicating parking stalls are designated on the surface of a street, no person shall park, stand, or stop any vehicle unless such vehicle is entirely within the limits of such parking stall.

Section 2. That Chapter VIII, Article 6, of the San Diego Municipal Code be and it is hereby amended by adding Section 86.02.2, to read as follows:

SEC. 86.02.2 EXCEPTION

The provisions of Section 86.02 shall not apply to a duly licensed commercial passenger bus if the variations from the requirements of said section are reasonably necessary to accomplish the loading or



unloading of passengers on or from such vehicle for a period of time necessary to accomplish said loading or unloading of passengers.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

When lines indicating parking stalls are designated on the surface of a street, or person shall park, stand; or stop any vehicle unless such vehicle is entirely within the limits of such parking stall.

Section 2. That Chapter VIII, Article 6, of the San Diego Munletgall Code be and it is hereby amended by adding Section 86.02.2, to read as follows:

SEC. 86.02.2 EXCEPTION

The provisions of Section 86.02 shall not apply to a duly licensed commercial passenger bus if the variations from the requirements of said section are reasonably secessary to accomplish the loading or unloading of passengers on or from such vehicle for a period of time necessary to accomplish the loading or unloading or unloadin
