

RESOLUTION NO. 215022

Adopted on JAN 7 1976

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Joel G. Halbert	ENGINEERING & DEVELOPMENT	\$1,000	Mr. Halbert is an Assistant Civil Engineer. He observed that developments in the concrete industry had upgraded mixes of concrete. He felt that the City should change concrete specifications for certain purposes so that less cement would be required in the mix. This has been done, and it is estimated there will be a saving of \$16,657 per year by the Street Division in its uses of concrete.
Alvin W. Broyles	WATER UTILITIES	\$150	Mr. Broyles is a Principal Utility Supervisor. A special problem developed in a sewer excavation that was below tidewater level, and water would return after removal. Mr. Broyles and several others were seeking solutions to the problem, and outside contractors quoted from \$1,500 to \$12,000 to set up their equipment to remove the water in the trench during the project. Mr. Broyles came up with the idea of using some pumps already on hand, but with an adapter he designed for the purpose. This was tried and found to work well. This precluded a cost of at least \$1,500 and can be used in the future if this problem occurs again.
