

RESOLUTION NO. 215023Adopted on JAN 7 1976

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Laurel A. Weiler	POLICE DEPARTMENT	\$45	Ms. Weiler, an Intermediate Typist, suggested elimination of a coding process for accident reports. Although this was no longer of use, coding continued for a long period afterward. A saving of \$430 worth of clerical time per year will result.
Phillip E. Reyes	PROPERTY DEPARTMENT	\$45	Phil Reyes is a Utility Worker I, and he became concerned with the damage to many of the numerous hose bibs throughout the San Diego Stadium. He suggested brazing a bolt onto the stem which should prevent virtually any further damage. This will save \$440 per year in parts and labor.
Calvin C. M. Chong	ENGINEERING & DEVELOPMENT	\$25	Mr. Chong, an Assistant Civil Engineer, became aware that the first sheet on a multitude of engineering plans really serve no important purpose and suggested they be discontinued. This seemingly minor change saves \$251 worth of material per year.
Frances L. Davis	BUILDING INSPECTION	\$10	Ms. Davis is Senior Typist in Noise Abatement and Control. She felt the design of the window envelopes used cost too much because they had to be made by an outside printer. She suggested a change so they can be printed in our own Print Shop. Even with small volume a saving of \$74 has been made.
Otto D. Wilkinson	GENERAL SERVICES Buildings Division	\$10	Buildings Service Technician Wilkinson proposed lighting Library flags so they could remain flying at all times. This would save \$367 a year, but would use energy. Reduction in days flags are flown will save \$112 per year labor.
