

RESOLUTION No. 215042Adopted on JAN 7 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Preliminary San Diego Regional Solid Waste Management Plan, 1975-2000, as presented to the 13 area cities and the County Board of Supervisors for public review and comment on November 10, 1975, a copy of which Preliminary Plan is on file in the office of the City Clerk, be and the same is hereby approved on condition that it be amended to indicate that the City of San Diego shall retain concurrent jurisdiction with the County of San Diego with regard to all facets of the Solid Waste Management problem.

BE IT FURTHER RESOLVED, that the Mayor and the City Manager are hereby authorized to meet with the Chairman of the Board of Supervisors and the County's Chief Administrative Officer to determine the makeup of the entity through which the City and County can exercise such concurrent jurisdiction.

BE IT FURTHER RESOLVED, that this resolution shall not in any way be interpreted as binding on the City with regard to resource recovery and specifically with regard to construction of a resource recovery plant but such a process and plant is merely approved in concept subject to further study.
