BE IT RESOLVED, by the Council of The City of San Diego as follows: *176-1353*

1. That the bid of \$72,213.96 by Viewland Investment Co., Inc., dba Viewland Construction Company, a corporation, for CONSTRUCTION OF STORM DRAIN AND SANITARY SEWER SYSTEMS FOR THE OFFSITE IMPROVEMENT OF THE SAN DIEGO COMMUNITY COLLEGE EDUCATIONAL AND CULTURAL COMPLEX, Schedule I, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 753119.
2. That the expenditure of \$98,000.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF STORM DRAIN AND SANITARY SEWER SYSTEMS FOR THE OFFSITE IMPROVEMENT OF THE SAN DIEGO COMMUNITY COLLEGE EDUCATIONAL AND CULTURAL COMPLEX, Schedule I, in the City of San Diego, and related costs.
