RESOLUTION OF INTENTION NO. 215061 JAN 14 1976

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THE NORTHERLY TEN FEET OF DWIGHT STREET BETWEEN MENLO AVENUE AND THE EAST SIDE OF 47TH STREET (CLOSED), EXCEPT 50 FEET IN 47TH STREET; AND VACATION OF THE ALLEY IN BLOCK C, BUNGALOW PARK ADDITION, MAP 1175, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the streets hereinafter mentioned; and in connection therewith require the reservation of a certain easement for sewer purposes in the area covered by such streets.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of the northerly ten feet of DWIGHT STREET between Menlo Avenue and the east side of 47th Street (closed), except 50 feet in 47th Street; and vacation of the ALLEY IN BLOCK C, Bungalow Park Addition, Map 1175, as more particularly shown on Map No. 16697-D, on file in the office of the City Clerk as Document No. 753922.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 8:30 a.m., FEB 18 1976, in the Council Chamber on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San


